DCPS is renovating these 3 schools this summer: Elliot-Hine Middle School, Stevens Elementary School, and Smothers Elementary School. The Wireless Access Points listed will provide wireless data services at those schools, both within the respective buildings and the outdoor areas around them. The equipment specified operates with the existing District-wide controller base and surveillance/control platforms currently in operation.
