

**A.4 Background**

OCTO/DC-Net operates and maintains the optical fiber voice/data network and wireless data services for the District of Columbia Government supporting the communications and data processing needs of the District and its various agencies including the schools, police, fire/emergency medical, and Unified Communications Center. DCPS is renovating these 3 schools this summer: Elliot-Hine Middle School, Stevens Elementary School, and Smothers Elementary School. The routers and switches connecting these schools to the District's fiber network and supporting the Ethernet connectivity within these schools is being upgraded. The equipment specified operates with the existing District-wide controller base and surveillance/control platforms currently in operation.
